**Method of payment-** Please choose one of the following methods:

1. Pay in Full – the entire amount for team fees, competition fees and apparel fees will be paid in advance. Biggest Savings!
2. Equal Payments – A \$50 payment plan fee is added to the total for team fees, apparel fees and competition fees and then divided into 4 equal payments. The first payment is due at registration and the remaining 3 payments should be post-dated for the 1<sup>st</sup> of each of the 3 following months. All payments must be post-dated and submitted at time of registration.
3. Monthly payments – A \$125 payment plan fee is added to the total for team fees, apparel fees and competition fees and then divided by the number of remaining months on your contract. The first payment is due at registration and the last payment should be no later April 1<sup>st</sup>, 2018. All payments must be post-dated for the 1<sup>st</sup> of each month and submitted at time of registration.

**Payment/Refund Policies:**

1. We accept Visa, Mastercard, Debit, Cheque or Cash.
2. Sibling discounts of 10% apply to each subsequent sibling after the primary sibling. The primary sibling is the sibling enrolled in the highest level program. Sibling discounts only apply to team fees.
3. To select an installment payment plan, please submit all post-dated cheques at time of registration. Date all post-dated cheques for the 1<sup>st</sup> of the month from the month you begin until April 1, 2017. Or, provide credit card details below.
4. A NSF of \$25 will be added to any returned payments.
5. Delinquent accounts must not exceed 60 days in order to remain in the program.
6. Any withdrawal requires written notice via email.
7. **Refund Policy** - applies to all withdrawals regardless of reason for cancellation (also applies to athletes that are removed from the program by the coaches/owner and regardless of payment plan.) Note – should you withdraw and you are on a payment plan, then you are still responsible for all fees according to this refund policy.
  - a. Less than 30 days – We will refund you 90% of your team fees, 100% of your apparel that has not been ordered from the manufacturer or worn by the athlete, and 100% any competition fees that have not been paid out.
  - b. 31-60 days – We will refund you 75% of your team tuition, 100% of your apparel that has not been ordered from the manufacturer or worn by the athlete, and 100% any competition fees that have not been paid out.
  - c. 61-90 days – No team fees will be refunded. 100% of your apparel that has not been ordered from the manufacturer or worn by the athlete, and 100% of any competition fees that have not been paid out.
  - d. More than 90 days – No refund on any fees.
